- I. **Call to Order** @ 7:06p.

 - 3. Began a section coordinator role that helps with music, covering parts when people are absent and general coordination

Thanks to John Pasquale for his time selecting music and conducting the band during rehearsals and the concert; Michael Haithcock for the use of Revelli Hall; Susan Sutherland for copying and coordinating music; Cary Kocher and Melissa Overheiser at Forsythe Middle School for allowing us to use their band room and equipment for our June 6 concert; and, Katie McCoy at the Ann Arbor Public Schools for her assistance with scheduling.
- 5. Concert Band cost is running \$1200-\$1500 a session.
- 6. Collect a \$20 participation fee. Collect separate donations for conductor with a minimum of \$500.
- 7. Concert promotion is underway. Doing more targeting of local ann arbor middle/high school bands along with local community homes. Will evaluate to see if it made an impact this summer.

- 9. Discussed conductors and having an alumni conductor for a song or two in the Fall session.
